### **EMERGENCY OVERVIEW**

Opaque, white liquid with an orange fragrance.

Eye irritant. May cause burning and redness. May cause skin irritation. Can react with alkaline materials or metals. Can emit toxic fumes if mixed with products containing chlorine or other sanitizing ingredients. Not a fire hazard.
