3. HAZARDS IDENTIFICATION

POTENTIAL HEALTH EFFECTS

This product has not been tested as a whole. However, this formula was reviewed by expert toxicologists in the Product Safety Assurance Department of Colgate-Palmolive and is determined to be safe for its intended use.
